



Affiliate Status Agreement

Conditions for Affiliate Status:

1. The annual subscription fee for Institutional Affiliate Status is €400. This will be payable each January upon receipt of an invoice. However, if ALTE and the Affiliate have a reciprocal arrangement on Affiliate Status for meetings of their organisations, the annual subscription fee will not be charged.
2. The Affiliate is allowed to send a maximum of three representatives to each ALTE meeting. The representative(s) may attend all of the ALTE meeting except the Annual General Meeting, Members' Update or other parts of the meeting specifically designated for ALTE members only.
3. The charge for representatives attending ALTE meetings is €50 per head, payable in cash to the host institution at registration. The Affiliate will also cover the costs of accommodation and travel for the representative(s) attending.
4. Since the use of the ALTE logo is exclusive to Members of ALTE, the Affiliate agrees not to use the ALTE logo on any of its materials, nor to claim that it has Full or Associate Membership of ALTE.
5. The Affiliate may include its details in a section about Affiliate Status on the ALTE web site, with links between both sites.
6. Affiliate Status is given for a year at a time and will be reviewed by the Executive Committee each November, where a decision will be made as to whether to give Affiliate Status for a further year. It is also possible for the Affiliate to decide not to continue with the arrangement.

Thank you for your application to become an Institutional Affiliate of ALTE.


